For participants in the Major Medical Plan, an Employee Assistance Program (EAP) is being added to the Plan, administered by Aetna and known as Resources for Living. The EAP benefit provides up to 8 counseling sessions per issue (see below), and participants can call 24 hours a day for in-the-moment wellbeing support. Resources For Living is a program sponsored by the Plan that is available at no cost to you and all members of your household. Counseling sessions are available face to face, as well as video or chat therapy via Talkspace (see Talkspace section below). Services are free and confidential for a wide range of issues you may be dealing with, including:

- Anxiety
- Depression
- Family issues
- Grief and loss
- Relationship support

- Self-esteem and personal development
- Stress management
- Substance misuse and more
- Work/life balance

Additionally, the EAP program offers daily life assistance to help you find resources for:

- Care for older adults
- Caregiver support

<u>Talkspace</u> – Talkspace is an online therapy platform that makes it easy and convenient for you to connect with a licensed behavioral therapist — from anywhere, at any time. With Talkspace, you can send unlimited text, video and audio messages to your dedicated therapist via web browser or the Talkspace mobile app. No commutes or appointments needed. You'll continue to message the same therapist unless you request to change providers; your therapist will reply to you daily, during their business hours — five days a week.

counts as one visit; you can work on the same kinds of issues you'd see a counselor face-to-face to talk about.

Note: Many face-to face counselors offer video appointments. This is different from Talkspace and each video appointment counts as one visit.

Legal services - You can get a free 30-minute consultation with a participating attorney for each new legal topic related to things like criminal law, divorce, wills, elder law, estate planning, etc. If you opt for services beyond the initial consultation, you can get a 25 percent discount. You also have free access to legal documents and forms on your member website.

Financial services - You can get a free 30-minute consultation with a participating attorney for each new legal topic related to things like budgeting, credit and debt issues, college funding, retirement, and other financial planning. You can get a 25 discount on tax preparation services. You also have access to financial articles, calculators and a financial assessment on your member website.

Identity theft services — The program provides for one hour fraud resolution phone consultation or coaching about ID theft prevention and credit restoration. Services include a free emergency kit for victims.

Online resources - Your member website offers a full range of tools and resources to help with emotional well-being, work/life balance and more. You'll find:
