

SUMMARY ANNUAL REPORT

FOR OFFICE AND PROFESSIONAL EMPLOYEES INTERNATIONAL UNION LOCALS 30 AND 537 HEALTH AND WELFARE FUND

This is a summary of the annual report of the Office and Professional Employees International Union Locals 30 and 537 Health and Welfare Fund (the "Plan"), E.I.N. 95-6047601, Plan No. 501, for the year ended January 31, 2025. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of Office and Professional Employees International Union Locals 30 and 537 Health and Welfare Fund has committed itself to provide certain health and welfare benefits incurred under the terms of the plan.

Insurance Information

The plan has contracts with Kaiser Foundation Health Plan, Inc., United Concordia Dental Plans of CA, Inc, Vision Service Plan, UnitedHealthcare Insurance Company, Berkshire Hathaway Specialty Insurance Company and Health and Human Resource Center to provide certain benefits incurred under the terms of the plan. The total premiums paid for the plan year ended January 31, 2025 was \$4,584,164.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ended January 31, 2025, the premiums paid under such "experience-rated" contracts were \$62,168 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$52,281.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$13,955,868 as of January 31, 2025, compared to \$12,824,234 as of February 1, 2024. During the plan year, the plan experienced an increase in its net assets of \$1,131,634. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$7,253,999 including employer contributions of \$6,558,771 participant contributions of \$308,650, earnings from investments of \$382,121, and other income of \$4,457.

Plan expenses were \$6,122,365. These expenses included \$770,678 in administrative expenses and \$5,351,687 in benefits paid to or for participants and beneficiaries.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
